## Information Collection and Use

## Third Parties

We may use third parties to carry out certain activities such as Google Analytics. Our site uses analytics services provided by Google. Website analytics refers to a set of tools used to collect and analyse anonymous usage information, enabling us to better understand how our site is used. ## **Log Data**

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics. In addition, we use third party service Google Analytics that collect, monitor and analyse this.

## **Cookies**

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some areas of our Site.

## **Security**

The security of your Personal Information is important to us and we have system security measures in place to protect your Personal Information.

In the instance of a data breach, we will notify the data protection authority within 72 hours of discovery of a data breach.

## **Right to be Forgotten**

The right to be forgotten entitles you to have the data controller erase personal data and cease further dissemination of the data. The conditions of erasure include the data no longer being relevant to original purposes or a data subject withdrawing consent.
